James A. Cawood Elementary School is a rural K-8 school located in southeastern Kentucky with approximately 356 students. We are part of the Harlan County School District. Harlan County borders Bell, Leslie, Letcher, and Perry Counties, as well as the state of Virginia. 88.5% of our students are economically disadvantaged. Out of our 356 students, 54.2% are male and 45.8% are female. 94.7% of the students are White, 1.6% are African American, 3.4% are Hispanic. Our student to teacher ratio is 14:1. Our teachers have an average of 13.6 years of teaching experience. 31.6% of our teachers have attained Rank 1 certification and 36.8% have a Master's degree. The JACES has 24 students in grades 4-8 formally identified as gifted and talented in one of the 5 categories, and 10 students identified in grades K-3 in the Primary Talent Pool. Jaces has zero teachers certified in Gifted Education and offers no pull out program for gifted and talented students.

Our Acronym for JACES is: J - Joining as a dedicated professionals to A - Attain a C - Community of parents and E - Educators who inspire and expect all S - Students to achieve their educational goals The VISION of JACES is to empower all students to become self-sufficient in all aspects of knowledge available to learners through the use of literature, technology, research, and curriculum so that each and every learner advances on the cutting edge of all latest innovations available.

We are one of the most improved schools in the state over the last 5-6 years. We have worked hard to change the culture and perception of our school and make it an environment for success. Our faculty and staff have worked hard with parents and stakeholders to make positive changes across the entire school. Recent KPREP scores show that our students are performing above both the state and district in many areas. Our Elementary School received a 4-Star rating while our Middle School received a 3-Star rating. Harlan County Schools hires a School Level District Gifted and Talented Liaison at each school to serve as a bridge in communication between the school and district GT Coordinator. The School Level GT Liaison works with regular teachers in the building to help identify, plan the GSSP and monitor the progress of Gifted and Talented students. The School Level GT Liaison regularly attends professional learning related to the needs of gifted and talented students and shares that information with teaching staff. The School Level GT Liaison participates in the district wide Identification and Placement Committee to engage in collegial conversation about gifted education with other GT Liaisons across the district. James A Cawood Elementary will utilize appropriate measures to increase the number of students identified in gifted education. Professional Development for regular education teachers relating to the identification and service of Gifted and Talented students will increase.
